Sub: Application for Letter of permission for functioning of Mahalaxmi Homoeopathic Medical College, Survey No. 259, At-Post – Raigaon, Tal – Jaoli, Dist. – Satara, Maharashtra - 415020 for admission with intake capacity of 60 seats for conducting Undergraduate (BHMS) course for the academic year 2023- 24- reg.

Sir,

Mahalaxmi Homoeopathic Medical College, Maharashtra has submitted an application for permission for sanction of 60 seats in BHMS course for the academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. Inspection of the college has been conducted on 23.08.2023 and 24.08.2023. MARB has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under NCH Act 2020. As per the observations made by MARBH, following lacunae are to be rectified with immediate effect. College shall fulfil all functional requirements as per the Minimum Standard requirements.

- a) On the 23/8/2023 (Inspection day 01)-08 patients were admitted, 04 patients since 22/08/2023 and 04 patients since 23/08/2023, out of them patients admitted on 23/08/2023 were directly admitted without OPD registration.
- b) Laboratory registers and stock register were incomplete and not present in the lab itself. Stock register had no reagent up gradation.
- c) Patho lab register had no data of August 2023.
- d) The displayed duty roaster of OPD/IPD were not updated.
- e) The Pharmacy/Dispensary was having some expiry medicines and not arranged alphabetically.
- f) OT, Labor room and X-ray room were not functioning.
- g) Guest faculty of Surgery & Pathology were not present on day of Inspection (as per the time table)
- h) Lab attendant and Lab assistant of Anatomy, and Physiology lab were not present on day of inspection.
- i) Case records should be well maintained in respect of case analysis, evaluation and repertorization and made available in Medical Records Room for academic purpose of

students and follow up attendance of patients. OPD/IPD case sheets should have complete demographic details and contact details of patients.

j) Diagnosis should be written in ICD 11 criteria.

Considering the above observations, and facilities available, MARB has decided to issue conditional permission to Mahalaxmi Homoeopathic Medical College, Survey No. 259, At-Post – Raigaon, Tal – Jaoli, Dist. – Satara, Maharashtra - 415020 for admission with intake capacity of 60 seats for A.Y. 2023-24. All shortfalls mentioned shall be rectified within a period of 30 days and compliance report shall be submitted to the undersigned, failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.
