Dist Satara Maharashtra – 415020 for continuing BHMS Course with intake capacity of 60 seats and opening new or higher course of study or training for PG Course with intake capacity of 18 seats in 03 subjects namely Materia Medica – 06 seats, Pediatrics – 06 seats and Practice of Medicine – 06 seats for the academic year 2025-26 – reg.

Letter No. 4-7/MARBH/NCH/2025-26(115-65)/6864 dated: 18/10/2025 is declared null and void.

Mahalaxmi Homoeopathy Medical College S. No. 259, At. Post Raigaon, Tal. Jaoli. Dist Satara Maharashtra – 415020 for continuing BHMS Course with intake capacity of 60 seats and opening new or higher course of study or training for PG Course with intake capacity of 18 seats in 03 subjects namely Materia Medica – 06 seats, Pediatrics – 06 seats and Practice of Medicine – 06 seats for the academic year 2025-26. The college has submitted part 1 information in which the entire functional profile has been narrated. MARBH Conducted inspection on 22.05.2025 and 23.05.2025 followed by physical hearing on 07.07.2025. The Medical Assessment and Rating Board has examined the college as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 and 28 of the NCH Act, 2020.

On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls:-

1. Teaching Faculty

- Department of Anatomy:** 1 Professor is not available.
- Department of Physiology:** 1 Associate Professor is not available.
- Department of Organon of Medicine:** 1 Associate Professor is not available.
- Department of Materia Medica:** 1 Associate Professor is not available.
- Department of Pathology:** 1 Associate Professor is not available.
- Department of Practice of Medicine:** 1 Associate Professor and 1 Assistant Professor is not available.
- Department of Surgery:** 1 Professor is not available.
- Department of Gynecoogy and Obstetrics:** 1 Associate Professor is not available.
- Department of Repertory:** 1 Professor is not available.
- PG Department of Homoeopathic Materia Medica:** 1 Professor is not available.

As evident from the above statement, a total number of 10 UG teachers are deficient against the requirement of 40+1 for 100-seats UG College (As specified in MES 2024). Pursuant to F. No. 3-2/MARBH/NCH/2025-26/162-169 dated: 16/04/2025 issued by MARBH, a college can avail 10% relaxation for 100 seats UG College against the required number of teachers for academic year 2025-26 only. After allowing relaxation of 10% college has 06 deficiency in teaching staff. However, such relaxed number of teachers may be appointed at the earliest for smooth conduct of course.

2. Miscellaneous

- i. College has not applied for NABL Accreditation for clinical laboratory.
 - ii. College is not marking attendance on AEBAS portal.
 - iii. METU available but not functioning.
 - iv. Salary of teaching and hospital staff is not as per MES 2024.
3. Considering the above observations and facilities available, MARBH has decided to issue permission for continuing BHMS Course with intake capacity of 48 seats and in compliance to the Ministry of Ayush letter no. R-11014/1/2024-EP-II dated: 24.06.2024. MARBH has reduced 07 seats. **Therefore MARBH has decided to issue conditional permission to Mahalaxmi Homoeopathy Medical College S. No. 259, At. Post Raigaon, Tal. Jaoli. Dist Satara Maharashtra – 415020 for continuing BHMS Course with intake capacity of 41 seats and for PG Course MARBH has decided denied permission to opening new or higher course of study or training for PG Course with intake capacity of 18 seats in 03 subjects namely Materia Medica – 06 seats, Pediatrics – 06 seats and Practice of Medicine – 06 seats for the academic year 2025-26.**
4. All admission shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 41 seats for BHMS course shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling authority of the State/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India Quota of the student admitted thereunder.
5. The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
6. Conditions under point 1 and 2 should be fulfilled within a period of 1 month and the compliance report shall be submitted for verification to the office, failing which permission for the academic year 2025-26 may be withdrawn.
7. If the college is aggrieved by the any decision of the Autonomous Board, college may prefer an appeal to the commission against such decision within 30 days of the communication of such decision as per National Commission for Homoeopathy (Assessment and Rating of Medical Institutions) Regulations 2024, section 14 subsection (1) and NCH General Regulation 2023 section 22. The Manner of instructions for appeal are attached.

With reference to letter No. 4-7/MARBH/NCH/2025-26(115-65)/6864 dated: 18/10/2025 is declared null and void.
